From Your Post Service Officer

The Department of Veteran affairs has streamlined the process for families of deceased veterans to receive a medallion indicating the Veteran status of the deceased.

These medallions are available only to veterans whose death occurred on or after November I, 1990. Secretary of the VA Eric Shinseki advises they have a new form (VA FORM 40-1330M) to be used for the medallion only. The medallion is available in three sizes: 5", 3", and I-I/2" width.

Each bronze medallion depicts a fold-

ed burial flag with the inscription "Veteran" and the branch of service at the bottom.

Next of kin may receive the medallion at no cost and affix it to the marker or have the cemetery affix it to headstone or burial location.

The medallion is available only to veterans buried in private and church cemeteries. For further information contact the VA at: 1-800-827-1000 or www.cem.va.gov/ hm.asp

"American Flag" Door Mats

A few weeks ago, I saw an Internet article stating that Lowe's was selling "American Flag" door mats. Several other Post members saw the article also. A check with Snopes' and Lowe's Web sites indicated that the door mat did not have an "American flag" per se represented on the mat but a pretty close representation of the "Stars and Stripes"—something close enough that I would not feel comfortable wiping my feet on it. (See picture, below.)

Steve Hose sent an e-mail to Lowe's expressing his concern. The reply, from Lowe's Customer Care stated:

"Lowe's offers home decorations, including mats made in the U.S. that have red, white and blue designs, but none of these mats shows the actual image of the U.S. flag.

We try to offer a variety of products that allow customers to express their personal pride, patriotism and love for our country.

We apologize if any of the designs on products in our stores were misinterpreted or our intentions were misunderstood. We meant no disrespect."

Bill Hose and I both brought up the subject at the Lowe's store in Hagerstown. The associate to whom I talked didn't know what I was talking about so we "Googled" the item. We looked around the store but didn't see any examples of that particular door mat. Another associate thought that they may have had the mats at one time but did not now. She didn't know if they had sold out or had been removed from inventory. The first associate to whom I talked tried to say that the mat didn't desecrate the flag. I told him that I strongly disagreed. He took a picture of the mat with his cell phone to show to other employees.

So, anyway, I think we may have stirred a little interest/knowledge in a couple of Lowes' employees' minds about flag desecration. I don't think they had any idea. (They are not veterans.) One employee did say that he has noted an increase in "patriotism" in the past year as he's seen a substantial increase in the sale of US flags and, especially, bunting. Thanks to all who expressed their concern.
