

Proposed Amendment to Post 222 Constitution & By-Laws

In accordance with the Post 222 Constitution & By-Laws, a proposed amendment to that document will be voted on by the attending membership during the Post meeting for the month of May 16, 2013. If you have any concerns or questions on this action, please plan on attending this meeting.

The current Post 222 Constitution & By-Laws reads as follows:

Article VI. Appointments

Section 3. House and Grounds Committee:

The House and Grounds Committee shall have full charge of the matters pertaining to the Post home and grounds. The committee shall be restricted to expenditures

for materials for sale and minor and emergency repairs. All major repairs and improvements shall be referred by the Post.

The proposed amendment to be voted on reads as follows:

Article VI. Appointments Section 3. House and Grounds Committee:

The House and Grounds Committee shall have full charge of the matters pertaining to the Post home and grounds. The committee shall be restricted to expenditures not to exceed \$500 for a single project total. Emergency repairs are excluded. All major non-emergency repairs (exceeding \$500) and improvements shall be referred to and voted on by the Post.
